b. Wisconsin Master Agriculturist Article

Lyle Ott who is a member of this committee and his family was given this award.

9. Items for Action or Discussion

a. Calumet County Farmland Preservation Survey

Payette and Mooney reviewed the executive summary and key elements of the survey. The response rate for completed surveys was 61%. Some of the main concerns in the farming community are cost of farmland, low commodity prices, difficulty in finding reliable employees and discord among small and large farms. Discussion followed.

b. NACO Analysis of Federal Infrastructure Plan

The Trump Administration introduced this plan earlier this year. The plan will create new grants with additional funding from state and government entities for rural infrastructure, transformative programs, expansion of existing loan programs and federal capital financing funds. Discussion followed.

c. Discuss Broadband Grant Opportunities

Payette reported staff is currently researching with Mary Kohrell two different broadband opportunities that may be available to Calumet County. The Broadband Expansion Grant program is administered by the PSC. The second program is called the Community Connect program and administered by the USDA. This program focuses on areas that lack variation speeds. Discussion followed.
