

# CALUMET COUNTY TRAFFIC SAFETY COMMISSION MEETING

**July 17, 2018**

The Calumet County Traffic Safety Commission meeting was called to order on July 17, 2018 at 3:30 p.m. by Jerry Koenig.

## **Election of Chair and Vice Chair:**

### Chair

A nomination for Glaeser was made by Koenig, seconded by Bowe. There were no other nominations. The vote for Glaeser was unanimous.

### Vice Chair

A nomination for Koenig was made by Glaeser, seconded by Katalinick. There were no other nominations. The vote for Koenig was unanimous.

A motion was made by Koenig, seconded by Bowe, to approve the Agenda for the July 17, 2018 meeting and the Minutes of the January 16, 2018 meeting. Motion carried unanimously.

**Public Participation:** None

**Committee Member Reports:** Olig informed the committee he will email them the legislation summary for the 2017 Legislative Session. Olig presented the Anatomy of Calumet County: A Traffic Safety Summary, which included information on traffic flows and volume, population and its trends, economy and employment, alcohol risk factors, injury to death ratios involving traffic crashes, number of EMT personnel and statistical data on crashes. Olig also did a presentation on Community Maps – WI County Traffic Safety Commission Crash Mapping.

The Governor's Conference on Highway Safety will be held August 21 through August 23, 2018 at Lake Geneva.

Bowe presented the year to date crash data. Bowe indicated there were two fatal crashes, both involving motorcycles, which occurred on 05/13/18 and 06/16/18.

Falk provided information of upcoming road projects:

- Resurfacing and culvert work on USH 10 from the roundabout at STH 32/57 in Forest Junction to CTH W in Manitowoc County – August to end of September
- Continuing construction on WI 441 project
- Mill and pave STH 55 from USH 151 to STH 114 – early August to early October

- Mill and pave USH 151 from the Calumet/Fond du Lac County line to Chilton – early August
- Chip and seal STH 32/57 from Hilbert to the Calumet/Brown County line – mid August

**Communications:** None

**Items for Action or Discussion:**

Discussion on Reduction of Speed Limit on CTH KK west of STH 55. Glaeser stated Outagamie County approached him indicating they wished to reduce the speed limit on CTH KK from State Park Rd. to STH 55 to a 45 MPH zone. They asked that we do the same on the south side of that section of the roadway. The committee recommended to the Highway Committee that this occur.

Discussion on Reconstruction of CTH N south of CTH KK. Glaeser informed the committee reconstruction of CTH N south of CTH KK was a potential project in the 2019 Capital Improvement Plan. The construction will either be a four lane roadway or a two lane roadway with center lane/turn lane.

Discussion on Reduction of Speed Limit east of HWY 10/57 Roundabout in Forest Junction. A discussion ensued regarding the request for a reduction in the speed limit on USH 10 east of the roundabout in Forest Junction. This was requested as there is a park located south of the Church Street/USH 10 intersection for which young children and people are crossing the highway to get to. It was noted a sidewalk infrastructure is not there for crosswalk permits to be granted. Also, speed is dictated by crashes. It was suggested the Town of Brillion could submit something and send to Rod Hamilton at DOT in Green Bay.

The next meeting date was set for Tuesday, October 16, 2018, at 3:30 p.m. in Room 017.

A motion was made by Gibler, seconded by Bowe, to adjourn the meeting at 4:40 p.m. Motion carried unanimously.
