The meeting was called to order by Highway Committee Chair Kenneth Draheim at 8:30 a.m.

**Moved** by Supervisor Barribeau, seconded by Supervisor Budde to approve the minutes from the September 12, 2018 Highway Committee Meeting. Motion carried unanimously.

**Items for Action or Discussion:**

- A. Discussion of CTH "N" Typical Section:** Commissioner Glaeser reviewed the typical sections that were presented at the September 12, 2018 meeting by Troy Robillard of Ayres Associates. The two options are to keep it as a four-lane road, or change it to a two-lane road with a center turn lane. **Moved** by Supervisor Budde, seconded by Supervisor Dietrich to stripe the road as a three -lane section with bike lanes. Committee discussion followed. On a roll call vote Supervisors Barribeau, Draheim and Mueller voted nay. Supervisors Budde and Dietrich voted Yea. Motion failed.  
A second motion was made by Supervisor Barribeau, and seconded by Supervisor Mueller to stripe and keep the road as a four-lane road. Committee discussion followed. On a roll call vote Supervisors Barribeau, Mueller and Draheim voted Yea. Supervisors Budde and Dietrich voted Nay. Motion carried.

- B. Discuss WCHA Updates:** Commissioner Glaeser informed the committee that Transportation is a big topic currently facing our Governor.
- C. Review/Approve Specification and Assign Dates Bids will be Due and Opened for the Purchase of One (1) New 2018 Excavator:** Highway Commissioner Glaeser explained that as a part of the adopted Personnel & General Administrative Policy the Highway Committee is to review and approve specifications for equipment as well as the dates for the bids to be due and opened for the purchase of equipment. Committee Discussion followed. **Moved** by Supervisor Budde, seconded by Supervisor Barribeau to approve the Specifications and Assign the Dates Bids will be Due, and Opened for the Purchase of one New 2018 Excavator. Motion carried unanimously.

Review/Approve Specification and Assign Dates Bids will be Due and Opened for the Purchase of One (1) New 2018 Fuel Monitoring Equipment Upgrade:** Highway Commissioner Glaeser explained that as a part of the adopted Personnel & General Administrative Policy the Highway Committee is to review and approve specifications for equipment as well as the dates for the bids to be due and opened for the purchase of equipment. Committee Discussion followed. **Moved** by Supervisor Budde, seconded by Supervisor Barribeau to approve the Specifications and Assign the Dates Bids will be Due, and Opened for the Purchase of one New 2018 Fuel Monitoring Equipment Upgrade. Motion carried unanimously.
